2016 Louis Lundgren Award Recipient

MINNEAPOLIS, MINNESOTA – **David L. Andersen, AIA**, architect and consultant at Andersen by Design, LLC, is the recipient of the **2016 AIA Minnesota Louis Lundgren Award**.

Directly related to his passion for helping young students develop creativity and leadership, David volunteered as a coach for Odyssey of the Mind, a nonprofit international creative problem-solving program for kindergarten through college-aged students, and judged the Hugh O'Brien Youth Leadership Awards.
