MINNESOTA DESIGN TEAM

What is your Design Team Story?

We all learn by hearing stories. They tell us what's important. So as we work to transform, we've reached out to architects who have been a part of the "team" over the last thirty-five years and asked them to share their stories. Here is a third one:



Rather than tell one story let me share a few highlights from some of my visits. I have served as committee chair, volunteer, co-leader and mentor for 14 visits including one in Wisconsin. My first introduction to the Design Team was through Michael Schroeder who connected me to Rich McLaughlin. Rich "interviewed" me and then added me to the teams for Houston and Preston just after I had moved to the Twin Cities. My first co-lead was with John Barbour for Two Harbors with strong support from

Mike Fischer and Michael Schroeder. Schroeder was interviewed by Kathy Wurzer for MPR on Saturday; the RR bridge you drive under coming into town was his rubble-stone design concept that the RR and MNDot built.

In rare metro-area community visits I mentored the Columbia Heights team (and bunked in the city managers house) and also served on the Lake Elmo team. During this visit Tim Griffin and Rich McLauglin illustrated how a cluster development could allow new housing at a certain density while still maintaining 75% open space (a big issue for the city). That allowed the city support for creating and adopting a new cluster zoning ordinance (maybe the first in the cities) that developer Bob Engstrom (who served on the Preston visit) used to implement his nationally known 'Fields of St. Croix' project (one of the earliest examples of applying "structured wetlands" to treatment waste water).

I led or served on post-disaster visits to 4 communities: St. Peter, Wadena, Rushford and Hammond/Zumbro Falls. In Rushford the team included 2 PhD's, 3 published authors as well as market, housing finance and stormwater management specialists. Among several outstanding recommendations, including a new library and elementary school (that was eventually state funded), was the proposal to create a new watershed management organization, based on U of MN MLA candidate Mitchell Cookas' capstone project. The WMO was adopted and has been a critical help to the regional watershed and rural land owners in maintaining stormwater run-off using best management practices.

In Wadena, after an initial meeting with about three dozen community leaders, state elected officials and representatives from Senator's Franken and Klobuchar offices, the design team was put into action. We had over 250 people show up for the Friday night potluck, we were interviewed by MPR and the team's recommendations ultimately helped support the request for state emergency funding to rebuild the high school that had been destroyed by a tornado.

The Minnesota Design Team has been a consistent and time-tested source of community-based decision-making and inspiration for dozens of small towns throughout the state. I have been fortunate to have worked with such amazing and talented volunteers over the years and proud to have had a small role in keeping this AIA award winning organization in service to the citizens of Minnesota.
