Call to Action

AIA Minnesota's mission of "advancing a vital profession, vibrant communities, and architecture that endures" is more critical than ever in this current environment of deep economic uncertainty, and increased inequities

caused by climate change and a history of racial injustice. We are asking our members and colleagues industry-wide to spread the word and, if financially able, to participate in two upcoming, highly-valued programs to support AIA Minnesota:

Due to the impact of the economic downturn on our profession, registration for the A'20 MN Conference will be free to AIA members who have been laid off or furloughed, and to recent graduates who have not been able to secure paid work within the field.

Each year, AIA Minnesota relies on the Homes by Architects Tour (HBAT) and the Minnesota Conference on Architecture together for approximately 1/3 of our overall revenue. Due to the pandemic and inability to meet in person, the HBAT net revenue goal has been decreased by an estimated 50% and the Conference net revenue goal has been decreased by an estimated 10%. We are hopeful, but not confident, that these revised goals will be met and we can enter 2021 with a somewhat optimistic financial outlook.

It is important to note that AIA Minnesota, a 501(c)(6) nonprofit organization, is not eligible for the many resources available to for-profit and 501(c)(3) nonprofit organizations, such as the Paycheck Protection Program (PPP) or relief programs that focus on the nonprofit sector. We have explored - and continue to explore - many opportunities for assistance, but the economic climate for nonprofit 501(c)(6) organizations is disheartening.

Even as AIA Minnesota has taken measures to reduce expenses, the staff has been busier than ever supporting our members in countless new ways: guidance on pandemic relief programs, like PPP and EIDL; Town Halls listening to member concerns; a Future of Design series collaborating with leaders from other industries; providing input to the State of Minnesota on reopening guidance for restaurants and bars; the MSP NOMA matching program for properties affected by the civil unrest; and reworking the formats of HBAT and the conference to accommodate a virtual environment. In the meantime, the following work - already underway - continues: growing our advocacy at the state legislature, increasing our trainings focused on design for climate action, offering new Intercultural Development programs, developing an action plan from the Culture Change Initiative to improve the culture of our profession, and shifting from the bimonthly Architecture MN magazine to ENTER - a digital weekly and print annual.

AIA Minnesota offers a multitude of valuable opportunities to share knowledge, access the expertise of industry colleagues, and advocate for our profession - but the greatest value is that of our collective professional community and the potential for change that we can accomplish together. AIA Minnesota is known for being a leader among AIA chapters and with your continued engagement, we can continue this important work. Thank you for attending the HBAT and the A'20 MN Conference. Thank you for encouraging and supporting others to do the same. Thank you for maintaining the strength of our architecture community.

Submit Your Project for the 2020 AIA Minnesota Honor Awards

Our Honor Awards acknowledge outstanding built projects by AIA Minnesota members, or firms that are owned by AIA Minnesota members, that practice professionally in Minnesota. We encourage broad participation from established and new practitioners of firms of all sizes - small, medium, or large.

There are two big changes to this year's AIA Minnesota Honor Awards:

- 1. In alignment with AIA National Architecture Awards, AIA Minnesota Honor Awards submissions will be evaluated using the <u>AIA Framework for Design Excellence</u>. Each entry should address, using narrative or metrics or both, the project's achievements in two or more of the ten design measures in the framework. Please note that submissions need not address all ten measures and that metrics are not required. To receive an Honor Award, a project must demonstrate excellence in two or more framework measures.
- 2. This year, we've added another opportunity for recognition: Commendations for Excellence in a single framework measure. The jurors may award up to ten Commendations, but they are not required to recognize an entry under each measure. For more details, visit the AIA Minnesota Honor Awards web page. Hope Remains for Bonding Bill in September Legislative Session

AlA Minnesota and our partners in the Building Jobs Coalition continue to advocate for passing a bonding bill in the September special legislative session. A <u>letter</u> was sent to Governor Walz and legislative leadership in late August, representing <u>more than 60 industry partners</u>, urging action. This was also sent to media outlets throughout the state. The Building Jobs Coalition is also planning an action alert day in September; watch your email for ways to support our advocacy for

In addition to the President of the United States and members of both the U.S. House and U.S. Senate, all members of the Minnesota House and Senate are on the ballot in November, making voting in this election extremely important.

NCARB ROLLING CLOCK EXTENDED

This month, NCARB will administer an additional six-month rolling clock extension to all passing exam scores that were valid as of March 1, 2020. Combined with the previous nine-month extensions, all valid exam scores will have received a total of a 15-month rolling clock extension. This ensures that no exam scores are impacted by the rolling clock until June 2021 at the earliest.

NCARB continues to pursue development and implementation of an online (or remote) proctored option for the ARE and recent progress will allow for an earlier-than-anticipated launch in late 2020.
