Homes by Architects Tour

The ninth annual Homes by Architects Tour drew more than 2,000 visitors during its two-day span on September 17-18, showcasing 17 new and remodeled homes designed by AIA Minnesota's residential architect members.



This year's tour featured the largest range in square footage among projects from all previous tours, from a 380-square foot accessory dwelling unit (ADU) in Minneapolis to a breathtaking estate perched atop a peninsula overlooking Lake Minnetonka's Wayzata Bay.

The tour also featured 29 sponsoring companies, more than in any other year of the event's history. Tour goers who responded to the post-event survey rated the tour a 4.5 out of 5, and 94% of respondents indicated they are likely to attend the tour again next year.



AIA MINNESOTA AWARDS

Robert C. Mack, FAIA, 2016 Gold Medal Award Recipient

Robert C. Mack, FAIA, is the recipient of the AIA Minnesota Gold Medal Award - one of the highest honors bestowed by the association. "Bob Mack is one of the founders of the historic preservation movement in Minnesota," says 2016 AIA Minnesota President Michelle Mongeon Allen. "He is the reason why many of Minnesota's most iconic landmarks are not only standing today but remain vital, relevant spaces for the future."

Outside of Minnesota, Mack has worked on more than 500 National Register properties and more than a dozen National Historic Landmarks throughout the country. "Anyone who has touched a preservation project in Minnesota has heard of Bob Mack," the Gold Medal jury noted. "He is the expert in Minnesota, and the reach of his work extends far beyond our state. He has furthered the profession of architecture and our communities through his tremendous contributions to the



Secretary of the Interior's standards and process related to preservation of historic structures."

LOCAL GOVERNMENT INNOVATION AWARDS

Do you know of a school, city, township, or county that has been innovating through design or services? In 2016, the awards' 10th year, the Local Government Innovation Awards (**#LGIAwards**) are recognizing a Top Innovator in addition to up to 20 local government entities.

The Top Innovator will receive recognition and the winner in each of the four categories will also receive a professional video highlighting their work and a \$5,000 grant from the Bush Foundation to continue local government innovation and redesign. More information at LGIA Awards.

25-Year Award

St. Elizabeth Seton Parish in Carmel, Indiana, designed by Rafferty, Rafferty, Tollefson, Lindeke Architects, Inc., is located on a 20-acre farm in a rapidly emerging suburb that was once a rural landscape dotted with farm buildings. The design of the parish buildings recalls that heritage by using strong, simple, rural forms. The jury noted, "This design shows an appreciation and understanding of rural vernacular buildings by skillfully organizing program components into individual building forms. These simple forms are then deftly collocated to allow an identifiable gathering common to emerge as the 'in-between' space. Timeless design and place-making strategies have likely



helped the community transition the social landscape between rural and suburban cultures since 1985."

Louis Lundgren Award

David L. Andersen, AIA, architect and consultant at Andersen by Design, LLC, is the recipient of the 2016 AIA Minnesota Louis Lundgren Award. David exemplifies the diverse range of volunteerism this award seeks to recognize. Owner of his design firm, Andersen by Design, LLC, David has merged his profession and outside interests into a career that has impacted local and international communities, global ecotourism efforts, youth groups, his church community, and the profession through his many roles with AIA.

efforts that contribute to the architectural profession. **Lee Anderson**, retired Associate Professor Emeritus, School of Architecture, College of Design, University of Minnesota, has shaped the role of technology in architecture at the University of Minnesota, influencing both the development and adoption of architectural representation software. **Lance LaVine**, Professor Emeritus at the School of Architecture, College of Design, University of Minnesota, is revered as a pioneer in energy, conservation and alternative resources and an expert on technology's role in architecture and humanity's understanding of nature. **Janet Streff**, retired from the State Energy Office, has provided vision and leadership of vast stakeholder groups in the design, construction and utility industries for over 20 years and shaped the CIP, B3 and SB 2030 programs in Minnesota into world-class energy conservation and efficiency activities.
